SUPPLEMENTAL INFORMATION REPORT December 1, 2017

The University of Puerto Rico at Cayey submits this Supplemental Information Report to address the concerns of the Middle States Commission on Higher Education (MSCHE) and all of its members regarding the recent natural disasters that have so devastatingly affected the island of Puerto Rico and our sister islands in the Caribbean. First, on September 5, Hurricane Irma struck, with severe damages to the electrical system. Soon after, on September 20, 2017, Hurricane Maria, with sustained winds of 155 miles per hour, wreaked havoc on the remaining electrical infrastructure, the telecommunications networks, and caused much property damage, as well as the collapse of the water distribution system. The region of Cayey, where our campus is located, received one of the strongest parts of the storm, and is slowly recovering.

The University of Puerto Rico in Cayey has taken the necessary measures to ensure continuity of all academic activities and services. One of the crucial first steps was to assess the damages to the campus structures with the help of University personnel and many volunteers. Between September 25<sup>th</sup> and October 27<sup>th</sup> meetings were held with staff, faculty and personnel to ensure that the academic term started following an orderly, uniform process for those affected, while taking into account, the highest academic standards mandated by the institution's mission. On October 23 thru 27 students were convene to receive information regarding the revised academic calendar and to assess their status and needs thru a student's census interview.

On November 6, 2017, classes began and faculty assessed the individual conditions of students and adapted course materials accordingly, thus considering the first week as a "soft-opening". Power returned on campus on November 15, which gradually allowed the use of technology in our daily activities. However, many of our constituents do not have power, water, or communications in residence and such we are making an effort to balance academic continuity with students' and employees' realities. The institution is committed to learn valuable lessons from this experience and adapt its best practices to ensure quality in education.

Below is a detailed account of the information requested:

- 1. Report the current operating status of the institution.
  - a. Is the institution currently closed?

This Institution is open and fully operational.

b. Has there been any damage to the institution?

The UPR-Cayey was heavily deforested by the impact of the storm. This in turn caused the destruction of the electrical and communications infrastructure. In addition, there were damages to building roofs, administrative offices, the main institutional fence that surrounds the institution, the campus houses that serve as temporally residences for students, faculty and visiting scholars, and extensive flooding inside many buildings causing damages to equipment and internal infrastructure.

c. Has there been any impact on the institution's ability to deliver student services or any of its academic programs?

The first semester, which had begun on August 21, 2017 continued on November 6, 2017 with an approximate attendance of 3,432 of its 3,497 enrollment (98%). Before classes

reconvened, the University was actively providing information, and cleaning the campus in preparation for receiving students, staff, and faculty.

The following provisions were taken in order to continue offering all of its academic programs and services:

- 1. Due to lack of electricity, all courses offered after 5:00 pm were moved to Saturdays.
- 2. The Registrar's Office was moved to the Informatics System Building (OSI) where a generator provided power.
- 3. A thorough assessment of classroom infrastructure was performed leading to the reallocation of spaces and the rental of two temporally tents to accommodate courses with more than 50 students, originally assigned to classrooms.
- 4. Science laboratories were powered by generators until power returned on November 15.
- 5. A photocopy machine was temporarily available for administrative and academic activities on the second floor of the Administration Building, enabling for professors to provide copies of class materials for students and also administrative tasks of our staff.
- 6. Due to the lack of internet, the library was available for making digital copies of materials to be shared with students on pen drives.
- Room 108 in OSI became a center for internet access for key offices of student services: Financial Aid, Planning and Assessment, Chancellor's office, Disbursement and the Registrar's Office.
- 8. On November 15 power was restored on some of the major buildings on campus. Currently, the remaining buildings are functioning with generators.
- 2. Describe the impact upon the academic calendar.
- a. Outline the academic calendar for the current term:

The Academic Calendar for the year 2017-18, as approved by Administrative Board (AB) Certification 51 (2016-17), began on August 21 and ran normally until September 5, when Hurricane Irma came. Due to these circumstances, the corresponding amendments to the Certification was approved by the Administrative Board. Classes reconvened after Hurricane Irma on September 11. Hurricane Maria led to an academic recess for recovery activities between September 17 and November 5. The Academic Calendar was amended by AB Certification 51 (2017-18); see attached calendars for details. (Appendix 2)

Classes resumed on November 6, 2017. The term will end on February 22, 2018. The second semester will begin on March 15 and end on July 9<sup>th</sup>, 2018. Commencement activities are scheduled for July 26, 2018. The summer session is scheduled to take place between July 12 and August 9, 2018.

i. When did the term start?

The term resumed on November 6, even though the original calendar started on August 21, 2017.

ii. What holidays and breaks were scheduled?

Holidays as schedule in the original calendar: September 4: Labor Day November 11: Veteran's Day November 20-24: Thanksgiving Break December 18 to January 8: Christmas Break

Holidays as scheduled on the amended calendar: First semester November 23-24: Thanksgiving December 24-January 7: Christmas Break

Second Semester: March 29-30: Spring break

End of first semester (February 22) and beginning of second semester (March 8, 2018)

iii. When was the term scheduled to end?

The term was scheduled to end on December 18, 2017.

b. Is it possible that the current academic term cannot be completed?

No, the current academic term will be completed.

i. If it can be completed, describe the steps being taken with regard to the academic calendar for the current term.

Please refer to the attached calendar.

c. Do you anticipate an impact on future academic terms?

Yes, the spring term originally scheduled to begin in January 2018, will initiate in March 2018 and will end in June 2018.

3. Does the institution have plans to establish a temporary site or sites for instruction? If so, describe the potential plans and include an address for any temporary site.

Courses that required computers as an essential part of instruction were temporarily moved to the Junior High School located across the campus. In addition, the program for talented high school students was relocated there.

4. Does the institution have plans to partner with another educational entity to deliver instruction to students? If so, describe and include the name or names of any prospective partner institutions.

The UPR system allowed students to transfer internally among campuses if they were unable to return to their original campus. This was approved by Governing Board (GB) Certification 54 (2017-18). The UPR-Cayey received 19 students from other UPR campuses. On the other hand, 18 of our students transferred to other UPR campuses.

5. Report on your institution's status with regard to Title IV student aid eligibility.

The institution is currently eligible under the Higher Education Act of 1965, as amended and has its corresponding Program Participation Agreement (PPA).

6. Institutions impacted by the hurricane are in various phases of the accreditation cycle. Describe any adverse impacts upon your institution's ability to support upcoming accreditation activities.

No adverse impacts on upcoming accreditation activities. UPR-Cayey is scheduled for MSCHE reaccreditation response in March, 2018.

7. Describe any other adverse impacts experienced by the institution that may be important for the Commission.

The most severe impact in the Institution has been due to the loss of power. Power was restored on November 15, making it possible to resume construction and repairs of damages, and to use all the technological resources available for instruction and administration duties. As power returns, limited telecommunications and internet is available. We foresee full restoration of services to support academic activity and student services, between December 2017 and January 2018.
